Hereinafter known as “Mare Owner”

Agrees to breed the mare \_\_\_\_\_  
Reg. No \_\_\_\_\_ to Bristol Encore B-39104, during the 200\_\_ breeding season, via cooled, shipped semen. Mare owner will pay a stallion service fee of \$\_\_\_\_\_. This includes a non-refundable booking fee of \$250.00. The booking fee is payable with this signed contract, and reserves a shipped semen breeding for said season.

This agreement is subject to the following conditions:  
Semen will not be shipped prior to payment of the booking fee and balance of the stallion service fee. Semen collection fee and shipping fee must be paid prior to shipment of collected semen. All collection and shipping fees may be paid directly to vet: Dr. Fred Haskin, 916-687-8803. We use the Federal Express Priority Overnight procedure. Collection and shipping fees for subsequent shipment (if needed) will be paid for by the mare owner. While we strive for quality and timeliness, no guarantee is given with regards to quality and no guarantee is given as to the responsibilities undertaken by FedEx to assure a timely deliver. The semen transport container must be opened and artificial insemination performed ONLY by a licensed veterinarian., All veterinary fees incurred by the mare owner for palpation, ultrasounds, insemination, etc. shall be paid by the mare owner.

The equitainer must be returned via FedEx or UPS at the earliest possible time. A fee of \$20 shall apply for each day starting on the 8<sup>th</sup> day and continuing every 24 hour period until the container is returned. If the equitainer or any of its components are missing, mare owner shall be billed for replacement.

The breeding season shall commence on March 15<sup>th</sup> and continue to August 15<sup>th</sup>. Special circumstances may extend the breeding season upon prior agreement. A week advance notice of the estimated date of collection would be appreciated. When the mare is ready for impregnation, contact should be made with Briarfair Farm at least 24 hours prior to the requested collection date. Once collection has been ordered, it cannot be cancelled.

Collection and shipping are subject to the show season. Please contact us for show dates. Semen can be shipped Monday through Friday **only**.

The mare must be healthy and in sound breeding condition. A copy of the mare's registration papers (if applicable) must be included with this contract. The mare owner agrees to use the shipped semen to breed only the designated mare in accordance with this contract.

If a licensed veterinarian determines that the mare is unsuitable for breeding, the mare owner may substitute a new mare, subject to acceptance by Briarfair Farm. This substitute mare shall be bred under the same terms and conditions as the original mare.

This contract provides for a return breeding for the following season (fee\$250), for said mare (or agreed upon substituted) that fails to produce a live foal. "Live foal" is defined as one that stands and nurses. This will be satisfied by re-shipping semen at the mare owner's expense (collection and shipping fees). In the event no live foal is produced, we must be notified in writing by a licensed veterinarian within 48 hours of birth.

The live foal guarantee mentioned in the paragraph above is expressly contingent upon the mare owner properly caring for the pregnant mare. Proper care shall include, but shall not necessarily be limited to, proper feeding and nutrition, regular deworming with products approved for pregnant mares, vaccinations that are customary in the mare owner's area and proper intervention during foaling if necessary.

Should the stallion die, be sold, or become unfit for service prior to conception with the above said mare the stud fee, less booking fee, shall be refunded.

Briarfair Farm Welsh Ponies, Irene Harvey, assistants or veterinarians, shall not be responsible for any sickness, disease or injury, which may come to the mare as a result of breeding with shipped semen.

When the mare owner signs and returns this contract, it becomes a binding contract on both parties, subject to the above terms and conditions. This contract is not transferable or assignable. The mare owner irrevocably agrees that his/her sole recourse against Briarfair Farm with respect to the performance or non-performance of this contract is the return of the stallion service fee, less the booking fee.

The terms of this contract shall be governed by the laws of the State of California.
